This permit is issued to Dr Morris and Dr Kolska for the export of 370 herbivore tooth samples from the Holocene layers of Wonderwerk cave. The powdered samples will be subject to isotopic analyses at the University of Oxford for palaeoenvironmental studies.

4. The samples must be kept for study purposes only, and may not be sold or exchanged.
5. The material may not be loaned to any person or institution other than Dr Liora Kolska without the consent of SAHRA.
6. The analyses will be undertaken at the University of Oxford by Ms Michaela Ecker.
7. A report on the activities undertaken in terms of this permit must be lodged with SAHRA before the end of May 2015.
8. Copies of any papers that may result from the export of the material must be lodged with SAHRA.
9. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
10. SAHRA reserves the right to cancel this permit by notice to the permit holders.
