3. All waste material and left over equipment will be removed from the site once the <u>construction</u> has been completed, and the site will be left in the manner it was found (save for the new <u>action</u>).

4. The landowner must be consulted before any intervention and <u>(permit holder)</u> or a representative of the landowner should be on site on the first day of the <u>action</u>).

5. It is understood that the **Bakopane Architects: Paul Johannes Labuschagne** will photograph the affected area prior to the <u>construction</u> and again after the <u>construction</u> has been completed.adn submitted to SAHRA with as built drawings highlighting any revisions.

6. A final report on the results of the activities in the form of a closing report should be submitted to SAHRA by *no later than 30 days after final completion of works by contractor on site.*

7. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and to ensuring that she has an understanding with the landowner concerning: the number of visitors and workers; speed limits on access roads; possible prohibitions on off-road driving; size, type and number of vehicles permitted; possible prohibitions on trespassing beyond the site; disturbing fauna, flora or substrate; appropriate hours of visiting and working on the site; use of firewood, electricity and water; lighting fires and the prevention of uncontrolled fires and any fencing necessary to protect livestock.
