## **PERMIT: Remove from its original position**

### **In terms of Section 36(3) of the National Heritage Resources Act (Act 25 of 1999)**

**Site:** Motshabi Sebobe Grave Disake Village (Motshabi Sebobe Grave)

Exhumation of the grave of Motshabi Sebobe's grave from its current location in Disake Village along the Main Road and in between taverns in Disake Village and relocate to Mmangwato Grave Site in Disake Village. The family of Motshabi Sebobe (born Maise) requested this as they want to have the grave reburied in a more suitable location.

This permit is allocated for the exhumation and relocation of Motshabi Sebobe as per section 36 of the NHRA 25 of 1999.

#### Conditions:

1. If the permit holder is not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorized representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a site plan.
3. A standard site record form must be lodged on SAHRIS.
4. Human remains must at all times be handled with respect and graves should not be disturbed except where unavoidable. The consultation procedures as indicated in the Regulations and the National Heritage Resources Act must be observed as appropriate. The recommendations for removal of graves and exhumations and for re-burial stipulated in SAHRA's Policy 'What to do when graves are uncovered', section 3, must be observed as far as possible.
5. A permit report is due by 30 April 2020. A preliminary report must be submitted within three months from the date this permit is issued.
6. All remains recovered, including relics and artefacts, as well as field notes and records, must be reburied with the skeletal material at the municipal cemetery.
