PERMIT: Remove from its original position

In terms of Section 36(3) of the National Heritage Resources Act (Act 25 of 1999)

Permit Holder: Mr Tobias Coetzee

Site: Jeremiah Nyathi Grave on Farm Enkeldoorns (Jeremiah Nyathi Grave)

Martins Funeral Services has been appointed by Kgomo Paulus Mdluli to affect the relocation of the grave of the late Mr Jeremiah Nyathi from portion 7 of the farm Enkeldedoorns 35 JT in Lydenburg, Mpumalanga Province, South Africa. Mr Nyathi was born in 1891 and died in 1945 after a long illness on a farm where he used to work. This permit is allocated to Mr T. Coetzee who is the responsible Archaeologist for this project.

Conditions:

1. If the permit holder is not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorized representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of site.
3. A standard site record form must be lodged on SAHRIS.
4. Human remains must at all times be handled with respect and graves should not be disturbed except where unavoidable. The consultation procedures as indicated in the Regulations and the National Heritage Resources Act must be observed as appropriate. The recommendations for removal of graves and exhumations and for re-burial stipulated in SAHRA's Policy 'What to do when graves are uncovered', section 3, must be observed as far as possible.
5. A permit report is due by **31 March 2019**. A preliminary report must be submitted within three months from the date this permit is issued.
6. All remains recovered, including relics and artefacts must be buried at a local municipal cemetery.
