## **PERMIT**

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

to: Dr Z Henderson.

of: the National Museum, PO Box 266, Bloemfontein, 9300,

for: the surveying, excavation and collection of items relating to historical occupation of the property, including investigation of the foundations and 'courtyard' of the original outbuildings and coal shed next to the thatched cottage on the property,

at: Liliesleaf,

in: Winston Street, Johannesburg,

in: the Sandton District, Gauteng Province.

## The following conditions apply:

- 1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
- 3. All material collected and excavated, as well as field notes and records, will be curated by the National Museum. All materials recovered will be curated on a temporary basis on behalf of the Liliesleaf trust until such time as the Trust requires the material for display purposes. Valuable items (such as weapons and ammunition) will be handed over immediately for safekeeping in the ABSA vault.
- 4. A report on activities connected with this permit must be submitted to SAHRA on or before 1 December 2005 and 1 December 2006 and a final report is due on or before 1 December 2007. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 5. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 6. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 7. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 8. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
- 9. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 10. SAHRA reserves the right to cancel this permit upon notice to the permit holder.
