PERMIT

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

- to: Mr J Hemingway (ID: 8006235020087) in association with Dr Francis Thackeray and Mr Justin Adams,
- of: the School of Anatomical Sciences, University of the Witwatersrand, 7 York Road, Park Town, Johannesburg, 2193,
- for: recovery and collection of fossil material from Luleche dump site,
- at: approximately 25 49.990S, 27 51.358E,
- on: the farm Broederstroom 481JQ,
- in: the Brits District, North-West Province.

The following conditions apply:

- 1. This permit will only be converted to an excavation permit for *in situ* deposits
 - after:
 - 1) mapping of the *in situ* deposits
 - 2) submission of a research proposal detailing the intended programmed excavation.
- 2. It is understood that appropriate measures will be taken to minimize environmental impact and disturbance, which will be discussed with GDACE.
- 3. Efforts must be made to return to the community the knowledge and expertise accumulated during the process.
- 4. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 5. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
- 6. A standard site record form must be lodged with the NFI Transvaal Museum.
- 7. All material collected and recovered, as well as field notes and records, will be curated by the NFI Transvaal Museum.
- 8. A progress report must be submitted to SAHRA on or before 1 February 2006 and 1 February 2007 and a final report is due on or before 1 February 2008. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 9. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 10. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 11. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 12. It is the responsibility of the permit holder to protect sites during and after collection and recovery of fossil material to the satisfaction of SAHRA and the landowner.
- 13. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 14. SAHRA reserves the right to cancel this permit by notice to the permit holder.
- This permit is valid until 1 February 2007.
