The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA: The materials in this permit will be sent to Germany for leaf wax analysis in the second phase of the study, SAHRA must be alerted in writing prior to the material being transferred.
7. No destructive analysis or sampling may be undertaken.
