The permit is issued to Prof. Christopher Henshilwood (ESI, Wits University), on behalf of Jovana Milic (University of Bergen), to permanently export 187 shellfish samples from Blombos Cave, southern Cape. The material is currently housed at the University of the Witwatersrand Satellite Laboratory in Cape Town.

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site, and the name and address of the permit holder.
3. The material will be couriered via DHL to the University of Bergen, Norway.
4. Jovana Milic under the supervision of Dr. Karen Loise van Niekerk is responsible for the analysis of the material and its transport to and from the above mentioned institutions/collections.
5. The samples must be used for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA: The samples covered under this permit as well as any reports and field notes will be sent to the Iziko Museums of South Africa, Cape Town for permanent curation.
7. Destructive analysis or sampling may be undertaken.
