**Site:** Site 1 Open-Air Stone Age & Iron Age (2430CC/Spitskop 333 KT/Site 1, 2430CC/Spitskop 333 KT/Site 2, 2430CC/Annex GrootBoom 335 KT/Site 3, 2430CC/Annex GrootBoom 335 KT/Site 4)

This permit is issued to Anton Pelser of APAC for archaeological mitigation of four Open-Air Stone Age and Iron Archaeological Sites in the area of Open Cast 3 (OC3) (Sylvania Lannex 1-4), to be impacted on by the expanding Mining Operations Sylvania Lannex, near Steelpoort, Limpopo Province.

  detailed site list (spreadsheet) must be created describing each site in detail (character, period, type,
  GPS coordinates etc..)
- 4. This permit covers Four (4) sites in the area of **Open Cast 3** (OC3) **(Sylvania Lannex 1-4)** and any new sites that may be discovered during survey under this permit (3288) and that will be impacted on by the development.
- 5. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act No 25 of 1999 must be employed. Note that the position of all excavations and objects collected must be marked on a site plan.
- 6. A standard site record form must be lodged with the Lydenburg Museum, Mpumalanga Province.
- 7. All material collected and excavated, as well as field notes and records, will be curated by the Lydenburg Museum, Mpumalanga Province, who will be responsible for the permanent curation and safekeeping of all excavated and collected material in a condition that allows ongoing research.
- 8. - 9. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
