This permit is issued to Mr Polke Birkholtz to allow for the destruction of eight archaeological sites on the farm Onderstepoort Ext. 33, 34A, B and C, Tshwane. SAHRA has received the mitigation report in support of the permit application to allow for the destruction of the eight sites. SAHRA is satisfied with the mitigation report.

Conditions:

1. If Mr Birkholtz is not to be present on the site at all times, SAHRA must be provided with the names and qualifications of the authorised representatives.

4. A final report must be submitted to SAHRA as soon as possible after the work has been done but no later than 30 September 2017.
5. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
6. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
7. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
8. SAHRA reserves the right to cancel this permit by notice to the permit holder.
