6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 30 April 2018.
7. Copies of any papers that may result from the export of the material must be lodged with SAHRA. A report must be submitted to SAHRA on or before 30 April 2018.
8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
