## **PERMIT: Export (Permanent)**

**In terms of Section 32(19) of the National Heritage Resources Act (Act 25 of 1999)**

**Object:** DNA-BONECOLLECTION-CASEID12274  
**To:** Mattias Jakobsson

**This permit issued for the Prof. Maryna Steyn in collaboration with Drs Helena Malmstrom, Carina Schlebusch and Mattias Jakobsson (Uppsala University and the University of Johannesburg) and Dr Marlize Lombard (University of Johannesburg), for the permanent export of 60 100-300mg samples for aDNA analysis and 9 samples for radiocarbon dating. It is noted that the aDNA analysis will be done at the University of Uppsala and the radiocarbon dating will be done at Beta Analytic, London.**

### **Conditions:**

1. The objects or specimens must be clearly marked with accession numbers.
2. The material must be carefully packed and all packaging must be clearly marked with the accession numbers, the name of the site, and the name and address of the permit holder and the University of Witwatersrand.
3. Specimens from the Eastern Cape and Kwa-Zulu Natal may require a permit from the relevant competent heritage authority for approval of destructive sampling. SAHRA must be notified in writing if the need to obtain a separate permit is waived by the relevant competent heritage authorities.
4. The material will hand carried by Dr Helena Malström to the Uppsala University, Sweden
5. The samples must be kept for study purposes only, and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than Prof. Mattias Jakobsson without the consent of SAHRA.
7. SAHRA must be notified in writing of the return of any material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 30 September 2020.
8. Copies of any papers that may result from the export of the material must be lodged with SAHRA. A report must be submitted to SAHRA on or before 30 September 2020.
9. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
10. SAHRA reserves the right to cancel this permit by notice to the permit holder.
