**In terms of Section 36(3) of the National Heritage Resources Act (Act 25 of 1999)**

**Site:** Dwars Rivier (DR-001, Richmond road - Dwars rivier)

**For the reburial of human remains uncovered at site ID DR-001, also known as Site ID Richmond road - Dwars Rivier, on farm Dwars River 372, near the Two Rivers Platinum Mine, Limpopo Province. The human remains will be reburied at the AAP Mototolo Der Brochen cemetery situated on the Farm Mareersburg 8JT, Greater Tubatse Local Municipality, Limpopo Province.**

Conditions:

1. This permit is issued to Mr Johan Nel (Anglo American Platinum)
2. If the permit holder is not to be present on the site at all times, then SAHRA must be provided with the names and qualifications of the authorised representatives.
3. Human remains must at all times be handled with respect.
4. The human remains must be reburied in a basic coffin, and grave markers noting the age of the remains must be placed on the graves. The SAHRIS Site IDs and cemetery plot number must be visible on the back of the grave markers.
5. All material collected and excavated during the initial relocation must be interred with the remains.
6. A standard site record form must be lodged with SAHRA.
7. A final report on the results of the reburial must be submitted to the case as a Heritage Report file by the date of the expiry of the permit using the template in the following link: <https://sahris.sahra.org.za/content/apmpermitreports>. Sections A,B C, D, F and K of the report template are relevant. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory. No

information protected by POPIA must be included in the report. If there is a delay in submitting the report, SAHRA must be informed in writing.

8. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.

9. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and the excavator is responsible for ensuring that he or she has an understanding with the landowner concerning: the number of visitors and workers; conditions for camping on the property; speed limits on access roads; possible prohibitions on off-road driving; size, type and number of vehicles permitted; possible prohibitions on trespassing beyond the site; disturbing fauna, flora or substrate; erection and demolition of structures on the site; appropriate hours of visiting and working on the site; use of firewood, electricity and water; lighting fires and the prevention of uncontrolled fires and any fencing necessary to protect livestock. Conditions of access imposed by the landowner must be observed.

10. The permitted excavator shall be responsible for the activities and impacts of all colleagues, students and employees under his or her supervision.

11. Permit holders must take measures to ensure the safety of any person who may enter the site as part of their team or as their visitor.

12. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.

14. SAHRA reserves the right to cancel this permit by notice to the permit holder.

15. This permit is subject to a general appeal and may be suspended should an appeal against the decisions be received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.

16. Request to renew permits must be done at least two months prior to the expiry of the existing permit.
