5. The material shall be returned to South Africa on or before 17 November 2015 at the expense of Dr. Fernando Abdala
6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 12 November 2015.
7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.

9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
