2. The material must be carefully packed and all packaging must be clearly marked with the accession numbers and the name and address of Prof. Marlize Lombard.
3. The material must be hand carried or sent via a reputable professional courier service unless written instructions to the contrary have been received from the repositories, the Kwa-Zulu Natal Museum.
4. The samples must be kept for study purposes only and may not be sold or exchanged.
5. The material may not be loaned to any person or institution other than Prof. Marlize Lombard and Prof. Mattias Jakobsson, who will be sending the samples to Oxford Beta in England, without the consent of SAHRA.
6. A draft report on the activities undertaken in terms of this permit must be lodged with SAHRA before the end of November 2015.
7. Copies of any papers that may result from the export of the material must be lodged with SAHRA.
8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
