## **PERMIT: Export (Permanent)**

**In terms of Section 32(19) of the National Heritage Resources Act (Act 25 of 1999)**

**Object:** Boomplaas cave flotation samples

**The permit is issued to Dr Justin Pargeter in collaboration with Dr. Anna Florin (Australian National University) to permanently export 172 flotation samples containing charred plant macrofossils from the archaeological site Boomplaas (BPA) Cave, ERF 30/33, Boomplaas, Cango Valley, Eden District, Western Cape, for destructive analysis. All the samples are accessioned by the Iziko Museum and currently stored at the Palaeoecology Laboratory at Nelson Mandela University in Port Elizabeth.**

Conditions:

1. Only the selected representatives of the material stored in the collection may be exported.
2. The material must be carefully packed and all packaging must be clearly marked with the name of the site (if known), and the name and address of the permit holder or the accessioning institution.
3. The material will be couriered to the Australian National University where Dr. Anna Florin will be responsible for destructive analysis.
4. Dr. Justin Pargeter is responsible for the transport of the material to the above mentioned institutions/collections.
5. The specimens must be used for study purposes only and may not be sold or exchanged.
6. The material may not be loaned to any person or institution other than the above stated participants in the study, without the consent of SAHRA.
7. Destructive analysis or sampling may be undertaken. Unused or leftover samples must be returned to the accessioning institution.
