This permit is issued to Prof. Amanda Esterhuysen for archaeological excavation for middens A and B associated with the site Selonskraal, situated on the farm Selonskraal 317JQ, which lies about 9.5km to the west of the Magaliesberg, in the North West Province of South Africa. Additional mapping will also be undertaken with the aim of refining the existing LiDAR survey map.

Conditions:

1. If the permit holder is not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of site.
3. A standard site record form must be lodged with the University of Witwatersrand.
4. All archaeological material collected and excavated, as well as field notes and records, will be curated by the University of Witwatersrand.
5. An annual progress report on the results of the excavations and analyses must be submitted to the heritage authority issuing this permit on 31 July 2018, 31 July 2019, and a final report is due on or before 31 July 2020.
6. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with the heritage authority.
7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
8. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
9. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of the heritage authority and the landowner.
