**Object:** Klasies-T. sarmaticus opercula-BATCH-CASEID5967

**This permit is issued to Ms Loftus for the export of 166 opercula of Turbo sarmaticus from Klasies River and Pinnacle Point for isotopic analyses. The opercula will be drilled with a micromill and returned to the repository.**

### Conditions:

1. The specimens must be clearly marked with accession numbers.
2. The specimens must be carefully packed and all packaging must be clearly marked with the accession numbers, the name of the site, and the name and address of Ms Loftus and/or the repositories.
3. The material must be hand carried or sent via a reputable professional courier service unless written instructions to the contrary have been received from the repositories.
4. The material may not be loaned to any person or institution other than Ms Emma Loftus without the consent of SAHRA.
5. The material shall be returned to South Africa on or before the end of October 2015 at the expense of Ms Loftus.
6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before the end of October 2015.
7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
9. SAHRA reserves the right to cancel this permit by notice to the permit holder.

This permit is valid from **02/10/2014 to 31/10/2015**.
