- 6. An annual progress report on the results of the excavations and analyses must be submitted to SAHRA by the end of May 2015, 2016 and 2017. A final report is due by the end of May 2018.
- 7. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
- 8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 9. It is the responsibility of Dr Schoeman to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 10. It is the responsibility of Dr Schoeman to fill in excavations and protect sites during and after excavation to the satisfaction of the heritage authority and the landowner.
- 11. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 12. SAHRA reserves the right to cancel this permit by notice to the permit holder.
