



## PERMIT: Excavation

In terms of Section 35(4) of the National Heritage Resources Act (Act 25 of 1999)

**Site:** Kathu Townlands 1 (Kathu Townlands) approximately at 27° 41' 30.66" S, 23° 3' 56.8656" E

This permit is for the excavation of five trenches within the Kathu Townlands site. SAHRA agrees with the position of the five archaeological trenches and the one geological trench as presented in Fig. 14 of the Proposed Work Plan and Current State of the Site document.

### Conditions:

1. If Mr Walker or Dr Morris are not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of site.
3. A standard site record form must be lodged with the McGregor Museum in Kimberley.
4. All archaeological material collected and excavated, as well as field notes and records, will be curated by the McGregor Museum in Kimberley.
5. A report on the results of the excavations and analyses must be submitted to SAHRA on or before the end of August 2014.
6. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
8. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
9. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of the SAHRA and the landowner.
10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
11. The heritage authority reserves the right to cancel this permit by notice to the permit holder.
