Conditions:

1. If Mr Pelser is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. RDR1, 2, 4, 7 and 9 must be surveyed and drawn and a layout plan must be compiled showing enclosure units, terracing, cattle tracts as well as artefacts and features.
3. A standard site record form must be lodged with the Lydenburg Museum.
4. All archaeological material collected and excavated, as well as field notes and records, will be curated by the Lydenburg Museum.
5. A progress report on the results of the excavations and analyses must be submitted to SAHRA by the end of January 2015 and a final report is due on or before the end of January 2016.
6. The report must specify and explain the relationship of all the excavated sites with the bigger settlement. The permit holder should ensure that reasons for contemporaneity are explained.
7. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
9. It is the responsibility of Mr Pelser to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
10. It is the responsibility of Mr Pelser to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
11. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
12. SAHRA reserves the right to cancel this permit by notice to the permit holder.
