- 9. It is the responsibility of Dr Hall to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
- 10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 11. SAHRA reserves the right to cancel this permit by notice to Dr Hall.
