Site: Swartkrans Palaeontological Site, Swartkrans 172, Krugersdorp District (9/2/233/0012) approximately at 25° 55' 45.0012" S, 27° 47' 20.0004" E

Conditions:

1. SAHRA has noted that a crew of six people, including a representative from the National Department of Tourism, will be on site during the filming at Swartkrans.
2. SAHRA understands that Dr Morris Sutton will monitor the filming at all times when the crew is on site.
3. The archaeologist must be consulted, prior to activities commencing on site, to advise the crew on any archaeologically sensitive areas which must be avoided. The archaeologist must also brief the crew on safety issues related to the site, as identified in the Risk Assessment report undertaken by the Management Authority for Swartkrans.
4. The amount of traffic, i.e. numbers of people on site, should be minimized as much as possible to avoid excessive disturbance of the site.
5. A report on activities related to the permit must be submitted to SAHRA on or before the 31st March 2014. SAHRA reserves the right to withhold further permits if a report is not received or is not satisfactory.
6. Reprints of all published papers, or copies of theses or reports/film resulting from this work must be lodged with SAHRA.
7. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and the applicant is responsible for ensuring that he or she has an understanding with the landowner concerning: the number of visitors and workers; speed limits on access roads; possible prohibitions on off-road driving; size, type and number of vehicles permitted; possible prohibitions on trespassing beyond the site; disturbing fauna, flora or substrate; appropriate hours of visiting and working on the site; use of electricity and water; lighting fires and the prevention of uncontrolled fires and any fencing necessary to protect livestock. Conditions of access imposed by the landowner must be observed.
8. The applicant shall be responsible for the activities and impacts of all colleagues and employees under his or her supervision and for their compliance with the terms of the permit.
9. It is the responsibility of the permit holder to protect sites during and after filming and to the satisfaction of SAHRA and the landowner.
10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
11. SAHRA reserves the right to cancel this permit upon notice to the permit holder.
