4. The extracted fossils and the remaining material shall be returned to South Africa on or before the end of October 2015.
5. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before the end of October 2015.
6. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
7. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
8. SAHRA reserves the right to cancel this permit by notice to the permit holder.
