In terms of Section 27(18) of the National Heritage Resources Act (Act 25 of 1999)

This permit is issued to Ms Lindsey Smith as representative of the Management Authority of the Cradle of Humankind World Heritage Site, which applied on behalf of Blue Wizard Productions represented by Ms Andile Masuku.

Conditions:

1. The heritage authority has noted the names of crew on site during filming to be as follows: Carl Nkosi, Lebo Moabi and John Pheko (Cameramen), Calien Palani (Sound man), Diliza Moabi (Director) and Surie Moodley (Production Coordinator).
2. SAHRA understands that either Ms Lindsey Smith of the Cradle of Humankind World Heritage Site Management Authority or Ms Lindsay Marshall from Maropeng will assist with monitoring. Such monitoring should take place at all times when your crew is on site.
3. The person responsible for monitoring must be consulted prior to activities commencing on site to advise the crew on any archaeologically sensitive areas which must be avoided.
4. The amount of traffic, i.e. numbers of people on site, should be minimized as much as possible to avoid excessive disturbance of the site.
5. A report on activities related to the permit must be submitted to the heritage authority on or before the end of November 2014. The heritage authority reserves the right to withhold further permits if a report is not received or is not satisfactory.
6. Copies of the film resulting from this work must be lodged with SAHRA.
7. It is the responsibility of the permit holders to obtain permission from the landowner for each visit, and they are also responsible for ensuring that they have an understanding with the landowner concerning: the number of visitors and workers; speed limits on access roads; possible prohibitions on off-road driving; size, type and number of vehicles permitted; possible prohibitions on trespassing beyond the site; disturbing fauna, flora or substrate; appropriate hours of visiting and working on the site; use of electricity and water; lighting fires and the prevention of uncontrolled fires and any fencing necessary to protect livestock. Conditions of access imposed by the landowner must be observed.
8. The permit holders shall be responsible for the activities and impacts of all colleagues and employees under their supervision and for their compliance with the terms of the permit.
9. It is the responsibility of the permit holders to protect sites during and after filming and to the
