## **PERMIT: Excavation**

### **In terms of Section 35(4) of the National Heritage Resources Act (Act 25 of 1999)**

**Site:** Greenpoint burials, Kimberley (Greenpoint burials)

This permit is issued for test excavations to be undertaken to understand the extent of the possible cemetery located in the Greenpoint area in Kimberley and affected by the establishment of a low-income residential development and associated infrastructure in the area.

#### Conditions:

1. If Dr Morris is not to be present on the site at all times, SAHRA must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all test excavations must be marked on a plan of site.
3. A standard site record form must be lodged with the McGregor Museum.
4. All archaeological material collected and excavated, as well as field notes and records, will be curated by the McGregor Museum.
5. An annual progress report on the results of the test excavations must be submitted to SAHRA by the end of April 2015. A final report is due on or before the end of April 2015.
6. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
8. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
9. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
11. SAHRA reserves the right to cancel this permit by notice to the permit holder.
