- If Mr. Reuben Phasha: Constitutional Hill is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorized representatives.
- All waste material and left over equipment will be removed from the site once the construction has been completed, and the site will be left in the manner it was found (save for the new action).
