Site: Remainder portion of the farm Blesbokfontein 38 IS, close to Ogies, Mpumalanga Province (Relocation of 15 graves from RE of the farm Blesbokfontein 38 IS)

PGS has been appointed by Glencore South Africa (PTY) Ltd (iMpunzi Complex) to affect the relocation of 15 graves located in an informal burial ground (ATC02) and conduct test excavations close to old farm worker houses located on the RE portion of the farm Blesbokfontein 38 IS, Mpumalanga. The graves will be affected by the expansion of coal mining in the area. According to the HIA conducted, there were farm worker houses in the area approximately 200m southeast of the burial ground. Test excavation needs to be conducted in this area to confirm if graves are present. This permit is allocated for the exhumation and reburial of all graves that fall under section 36 of the NHRA legislation and for conducting test excavation. Permission for graves that are not covered under this permit must be obtained from the responsible permitting authorities.

Conditions:

- 1. If the permit holder is not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorized representatives.
- 2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a site plan.
- 3. A standard site record form must be lodged on SAHRIS.
- 4. Human remains must at all times be handled with respect and graves should not be disturbed except where unavoidable. The consultation procedures as indicated in the Regulations and the National Heritage Resources Act must be observed as appropriate. The recommendations for removal of graves and exhumations and for re-burial stipulated in SAHRA's Policy 'What to do when graves are uncovered', section 3,
