4. The landowner must be consulted before any intervention and (permit holder) or a representative of the landowner should be on site on the first day of the action).

5. It is understood that Bakopane Architects: Paul Johannes Labuschagne will photograph the affected area prior to the construction and again after the construction has been completed and submitted to SAHRA with as built drawings highlighting any revisions.

6. A final report on the results of the activities in the form of a closing report should be submitted to SAHRA by no later than 30 days after final completion of works by contractor on site.
