 - Maintenance and repair of marine furniture on Government Jetty and Trawler Quay 1 (bollards, fenders and fixings);
 - Fencing off of the Dolphin Jetty.
- 4. This permit does not give authorisation for damage/disturbance of any cultural heritage material not mentioned in (3) above. In particular, permission is **not** hereby granted for the disturbance of any historic shipwrecks whatsoever. Should any cultural heritage material not mentioned in (3) be discovered and be at risk of damage/disturbance as the result of the activities undertaken under the authority of this permit, SAHRA must be notified immediately and work must cease and may not commence until feedback has been received
