Conditions:

1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of site.
3. A standard site record form must be lodged with the the Ditsong Museum of South Africa.
4. All archaeological material collected and excavated, as well as field notes and records, will be curated by the Ditsong Museum of South Africa.
5. An annual progress report on the results of the excavations and analyses must be submitted to SAHRA on the 31st of March 2014.
6. A specialist must be appointed to undertake the analyses of the ceramics, glass and the rest of the assemblage recovered from the midden context. A report from these analyses must be submitted to SAHRA on or before the 31st of March 2015.
7. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with the heritage authority.
8. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
9. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
10. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
11. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
12. SAHRA reserves the right to cancel this permit by notice to the permit holder.
