Issued under section 36 (3) of National Heritage Resources Act No 25 of 1999. Permission is hereby given: to: A.J. Pelser(7112235283088) of A.Pelser Archaeological Consulting cc.,431 The Village road Menlo Park for: the exhumation and relocation of a rescue burial of approximately 65 graves, located at 24 different location within the Farms Zandfontein 130 IS and Grootspruit 279 IS, at: the development corridor of the construction of a conveyor belt for Sasol Mining, Shandoni Coal,in; Secunda Magisterial District, Mpumalanga Province.

The following conditions apply:

1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualification of the authorized representatives
2. Adequate recording methods as specified in the regulations and guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of the grave must be marked on a plan of the site, and the site marked on a 1:50 000 map
3. Human remains must at all times be handled with respect. Minimum standards of documentation and photographic recording of human remains and associated with goods must be observed, subject to the approval of the descendants. The recommendations for removal of graves and exhumations and for a re-burial made in SAHRAs policy What to do when graves are uncovered, section 3,must be observed as far as possible
4. The relocation of the graves will be at Sasol Secunda Complex. Should the existence of additional graves be established during test excavations, SAHRA should be informed and a further application process be subsequently observed.
5. A report on the grave relocation and the test excavations must be submitted to SAHRA on or before 01 February 2014
6. Reprints of all published papers, or copies of these or reports resulting from this work, must be lodged with the relevant Provincial Authority and SAHRA.
7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
8. It is the responsibility of the permit holder to obtain permission from the land owner for each visit, and condition of access imposed by landowner must be observed.
9. It is the responsibility of the permit holder to fill in grave excavations and protect sites during and after excavation to the satisfaction of the SAHRA and the landlord.
10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as result of any activities in connection with this permit.
11. SAHRA reserves the right to cancel this permit by notice to the permit holder.
12. This permit is subject to a general appeal and may be suspended should any appeal against the decisions received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.
13. NB Any breach of the conditions of this permit will render this permit null and void

This permit is valid until 1 February 2014.
