1. This permit is for the temporary export of the right hemi mandible of specimen MH1, the holotype of *Australopithecus sediba*.
2. The specimen will be hand carried and analysed by Prof. Berger at the European Synchrotron Radiation Facility in Grenoble, France.
3. The specimen must be clearly marked with its accession number.
4. The material must be carefully packed and all packaging must be clearly marked with the accession number, the name of the site, and the name and address of the permit holder or of the European Synchrotron Radiation Facility in Grenoble, France.
5. The material must be hand carried or sent via a reputable professional courier service unless written instructions to the contrary have been received from the repository, the University of Witwatersrand.
6. The material may not be loaned to any person or institution other than Prof. Lee R. Berger without the consent of SAHRA.
7. The material shall be returned to South Africa on or before the 1st of November 2013 at the expense of Prof. Berger.
8. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before the 1st of November 2013.
9. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.


