This permit is issued to Mr Anton Pelsler APelsler Archaeological Consulting) to fence the following archaeological sites, Sites A, B, 12, 13 and 14 to prevent impact from the proposed Zeerust PV solar facility, North West Province.

Conditions:

1. If the permit holder is not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of site.
3. In the event that archaeological objects will have to be excavated during the course of fencing, the excavated material must be lodged with a recognised repository and SAHRA must be informed and provided a full inventory.
4. A final permit report is due by no later than the 31 March 2019.
5. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with the heritage authority.
6. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
7. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
8. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of the heritage authority and the landowner.
9. The heritage authority shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
10. The heritage authority reserves the right to cancel this permit by notice to the permit holder.
