This permit is issued to Dr David Morris (McGregor Museum) in collaboration with Prof. Michael Chazan (University of Toronto) for the temporary and permanent export of non-artefact materials and samples for dating and palaeoclimate analysis. It is noted that the archaeological materials and samples will be exported to various academic institutions.

Conditions:

4. The material may not be loaned to any person or institution other than to the academic institutions indicated in the permit application without the consent of SAHRA.
5. The material shall be returned to South Africa on or before 31 December 2020 or otherwise indicated by the McGregor Museum, at the expense of prof Michael Chazan.
6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 31 December 2020.
7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
