7. SAHRA must be notified in writing of the return of any remaining material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 31 December 2020.
8. Copies of any papers that may result from the export of the material must be lodged with SAHRA.
9. A report must be submitted to SAHRA on or before 31 December 2020.
