5. The material may not be loaned to any person or institution other than to Prof. Huisman (State Heritage Agency Netherlands) or Ms Sifogeorgaki without the consent of SAHRA.
6. SAHRA must be notified in writing of the return of any remaining material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 31 December 2020.
7. Copies of any papers that may result from the export of the material must be lodged with SAHRA.
8. A report must be submitted to SAHRA to apmpermitreports@sahra.org.za on or before 31 December 2020.
9. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
10. SAHRA reserves the right to cancel this permit by notice to the permit holder.
