This permit extension is issued to Dr David Pearce (Rock Art Research Institute - University of Witwatersrand) for the temporary export of 10 painted flakes from the site of Mount Tyndall 2, Eastern Cape Province, to Dr Christian Cappelli (University of Oxford) to undertake a pilot study to extract DNA from the paint.

Conditions:

1. The objects or specimens must be clearly marked with accession numbers.

5. The material shall be returned to South Africa on or before 31 December 2020.
6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 31 December 2020
7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.

9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
