## PERMIT: Excavation

**In terms of Section 27(18) of the National Heritage Resources Act (Act 25 of 1999)**

**Site:** DECLARED NATIONAL HERITAGE SITE : DAL JOSAPHAT FARM 1341 (GRADE 1 : DAL JOSAPHAT FARM 1341)

**This permit is for the excavation of three (3) geotechnical test trenches near the eastern boundary of Farm 1341, Daljosafat. It is noted that each test trench will be to a depth of 3.5 metres.**

### Conditions:

1. If Mr Gribble is not to be present on the site at all times then the heritage authority must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be employed. Note that the position of all excavations and objects collected must be marked on a plan of site.
3. A report on the results of the excavations and analyses must be submitted to SAHRA on or before the end of December 2020.
4. Please note that this permit does give explicit approval for the development of the pipeline.
5. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with SAHRA.
6. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
7. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
8. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of the SAHRA and the landowner.
9. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
10. The heritage authority reserves the right to cancel this permit by notice to the permit holder.
